JOSEPH P. INGRASSIA

Joe has been a member of the NYAC since 1949. After serving three years in the U.S. Army during WWII, Joe attended Syracuse University. After graduation, he was offered an athletic membership in the NYAC, subsequently winning three national handball doubles titles for the Club. Joe was also a top executive in the oil industry. He was elected to the NYAC Board of Governor's in 1969 and elected President in 1979. The establishment of the Hall of Fame on the second floor of the City House can, largely, be attributed to Joe's efforts. Joe and his wife Cele have three children, Patrice, Elizabeth and Paul and three grandchildren.

JOHN J. McDERMOTT

John, universally known as Jack, has been a member of the NYAC since 1946. A graduate of Fordham University and Fordham Law School, he served in the U.S. Navy from 1953 to 1956 as a Lieutenant aboard the USS Des Moines, a heavy cruiser attached to the Sixth Fleet in the Mediterranean. He was elected to the NYAC Board of Governor's in 1977, elected Vice President in 1982 and elected President in 1985. He was a partner in a number of law firms in NYC. Jack has been married to Jean McDermott since 1958. They have two sons, Keith and Stephen, and one grandson.

JOHN A. JOHNSON

John, better known as Jack, has been a member of the NYAC since 1969. He was elected to the Board of Governor's in 1979, elected Vice President in 1988 and elected President in 1991. After serving in the Army in WWII as an infantryman, he attended New Jersey Institute of Technology and graduated with a degree in Mechanical Engineering. He worked for twelve years as a Marine Engineer for the U.S. Navy. In 1962, he joined Treadwell Corporation where he became President and CEO. Jack and his wife Mary raised five children, Robert, Carol, Susan, John and Stephen. They have six grandchildren and two great grandchildren.
